1. \$45.00 registration fee is due per child at time of enrollment and includes a camp tee shirt. Payment in full for all days reserved is due at time of enrollment/reservation. Payment in full is due for the current month. A 10% deposit is needed for all future months to be reserved.
2. We require 24 hour advance notice for cancellation in order for you to receive a credit. No cash refunds will be given. If we are not notified of a cancellation the day before a reservation, no credit will be given.
3. Any field trip is subject to change for any reason without notice. If we must change or cancel an outing, we will make every effort to reschedule.

### What your child needs to have every day:

1. Your child must wear our camp tee shirt every day. Additional tee shirts are available new for \$12.00.
2. For your child to have the best possible experience here at Andi Panda Summer Camp, please be sure that your child is prepared for the event of the day including water – play and current weather conditions. Please have a weather appropriate change of clothing and shoes for your child every day. Our goal is to be sure that every child has a comfortable, safe and fun day in camp.
3. Sending a backpack with your child every day makes our outings much easier for them to carry lunches or changes of clothing. If possible, please send a backpack with your child for every field trip.
